

Modern Slavery Statement 2022

Introduction

This statement is made pursuant to section 54(1) of the Modern Slavery Act 2015 and constitutes Crown Communication Ltd's (Crown) slavery and human trafficking statement for the financial year ending 31st December 2022.

It reflects the approach taken by Crown in ensuring there is transparency in the company's supply chains responsible procurement of new suppliers and takings steps to prevent modern slavery.

Our Structure

Crown has an established office network covering Birmingham and the West Midlands.

Our whistleblowing policy includes a mechanism for reporting genuine suspicion of any criminal conduct or breach of a legal or professional obligation by anyone in the firm or the Group, or by a client or contractor, which includes instances of modern slavery.

Our Supplier Due Diligence Processes

As part of our efforts to monitor and reduce the risk of slavery and human trafficking occurring within our supply chain, all supplier reviews incorporate a review of the controls undertaken by the supplier to ensure compliance to the Modern Slavery Act 2015. Additionally, any proposed new supplier shall need to demonstrate their compliance before they can be considered for addition to the preferred Crown Communication Suppliers list.

Risk and Compliance

Crown has taken steps to evaluate the nature and extent of its exposure to the risk of modern slavery occurring in its supply chain. We do not consider that Crown operates in high-risk sectors or locations.

Crown does not tolerate slavery and human trafficking within its supply chains and would immediately seek to terminate its relationship with a supplier where evidence of a failure to comply with Crowns policies was discovered.

Measuring Effectiveness

We have taken the following steps:

1. established and assessed areas of potential risk in our businesses and supply chains;
2. monitored potential risk areas in our businesses and supply chains;
3. reduced the risk of slavery and human trafficking occurring in our businesses and supply chains;
4. and provided adequate protection for whistleblowers

Training for Colleagues

Our procurement process is communicated to all of our colleagues who have responsibility for supplier relationships. Our Purchasing Policy, which is regularly updated, incorporates our approach to forced labour, and this is made available to all colleagues.
